

### BACKGROUND, INSTRUCTIONS, AND LIMITATIONS

The below instructions have been created by Novartis to assist with setting up COSENTYX as a favorite, as well as setting up a custom medication, in the Cerner electronic health record (EHR) system. These instructions will not work for other conditions, treatments, or therapeutic areas, or on other EHR systems.

EHRs offer thousands of available medications at the provider's fingertips—making the process to find the appropriate medication time-consuming. Beyond selecting the medication, additional prescription details, such as the medication dosing, routing, frequency, etc, need to be completed, often duplicating previously entered information.

Setting up a medication as a favorite eliminates a repetitive process and allows a seamless e-Prescription process, without sacrificing clinical quality and patient safety. In rare cases, the medication may have to be added as a custom medication if not available. A custom medication lacks important safety precautions such as drug–drug interactions, drug allergy checks, and adverse events information.

### CERNER

#### Favorite Medication:

1. Select **Medications** or **Orders** in the navigator and select **+ Add** icon
2. Start typing **COSENTYX** and select **COSENTYX**
3. Complete the desired medication details for **COSENTYX**
4. Right-click **COSENTYX** in the **Orders for Signature** window
5. A new pull-down menu will appear
6. Click **Add To Favorites**
7. Select the desired Favorites folder and click **OK** to save **COSENTYX** as a favorite

#### Custom Medication:

1. Open **Dcptools.exe** and select **Order Management Tool**
2. Click on the **Order Catalog Tool**
3. Select the **Add New Orderable** checkbox
4. Enter **COSENTYX** and complete the desired medication details
5. Once completed, click **Apply**

Note: To remove the custom medication, open **DCPtools.exe**, select **Order Management Tool**, and enter **COSENTYX**. Select the **Modify Orderable** checkbox, highlight **COSENTYX**, and click the **Hide** radio button next to the product to remove the product.
