- Patient name and address
- Pharmacy name, address, and phone number
- Healthcare provider name, address, and phone number
- Prescription number, fill date, drug name, strength, National Drug Code number, and quantity
- Overall prescription price and co-pay amount paid
- A copy of the front and back of your prescription card
